Vorlesungsankündigung für das Sommersemester 2019

im Sommersemester 2019 die folgende Blockveranstaltung in englischer Sprache an:

An Introduction to International Criminal Law

fremdsprachige rechtswissenschaftliche Veranstaltung
im Sinne der §§ 9 I Nr. 3, 3 V S. 2 JAPrO.

The course provides an introduction to the rapidly-developing field of international criminal law. It will begin with an examination of the International Criminal Court and its predecessors, exploring their origins, structure, and jurisdiction *ratione personae* and *ratione materiae*. In addition to the four “core crimes” of genocide, crimes against humanity, war crimes and aggression, attention will be given to the various “modes of participation” such as incitement, solicitation, “joint criminal enterprise,” and command responsibility, as well as defenses such as self-defense, duress and superior orders. Because “international criminal law” operates simultaneously on the domestic as well as international levels, the course will also address the various international treaty regimes for prosecution of international crimes in domestic courts, including torture, organized crime, money-laundering and trafficking in drugs, people and cultural objects. We will explore the various treaties requiring states to criminalize and prosecute various crimes of terrorism, as well as the mechanisms of cross-border extradition and “mutual legal assistance.” The course will consist of both lecture-style presentations and seminar-style discussion. Students will be expected to participate in several exercises designed to provide some experience in how the courts operate in specific situations
